**FIRST AMENDMENT  
TO THE AMENDED AND RESTATED DECLARATION OF CONDOMINIUM OF  
STRATHMORE RIVERSIDE VILLAS, A CONDOMINIUM,  
SECTION TWO**

WHEREAS, the Amended and Restated Declaration of Condominium of Strathmore Riverside Villas, a Condominium, Section Two (the "Declaration") was recorded as Instrument #2005265830, in the Public Records of Sarasota County, Florida.

WHEREAS, the owners of the units subject to the provisions of the Declaration have found it necessary to amend this Declaration.

NOW THEREFORE, the owners in this Condominium, as members of the Strathmore Riverside Villas Association, Inc. (the "Association"), voted to amend Section 6.1(B) of the Declaration as follows:

(Words in ~~strike-through~~ type are deletions from existing text; words in double underscore type are additions)

6.1(B) Alteration and Improvement: After the completion of the improvements included in the Common Elements and Limited Common Elements which are set forth in this Declaration, there shall be no alterations or further improvement in the Common Elements or Limited Common Elements without prior approval in writing of not less than the ~~percentage of owners required by Florida Statute 718, as may be amended~~ two-thirds (2/3) of the total voting interests.


