**NOTICE OF OPT OUT VOTE  
RECORDED PURSUANT TO SECTION 718.111(11)(m), FLORIDA STATUTES**

WHEREAS, the Amended and Restated Declaration of Condominium of Strathmore Riverside Villas, a Condominium, Section One, was recorded as Instrument #2005265829, of the Public Records of Sarasota County, Florida;

WHEREAS, the Original Declaration of Condominium of Strathmore Riverside Villas, a Condominium, Section One, was recorded in Official Record Book 836, Page 207, of the Public Records of Sarasota County, Florida;

WHEREAS, Sections 718.111(11)(k) and (l), *Florida Statutes* (2008), state that any condominium may opt out of the provisions of Section 718.111(11)(j), *Florida Statutes*, regarding allocation of repair or reconstruction costs and expenses, and may allocate such repairs, costs and expenses in the manner provided in the Declaration as originally recorded or amended.

WHEREAS, the owners in this condominium have voted to opt out of the above-referenced provisions, and the purpose of this document is to record the notice as required by Section 718.111(11)(m), *Florida Statutes* (2008).

NOW THEREFORE, a majority of the owners in this Condominium, as members of the Strathmore Riverside Villas Association, Inc. (the "Association"), voted to opt out of the provisions of Section 718.111(11)(j), *Florida Statutes*, regarding allocation of repair or reconstruction costs and expenses.

1. The vote to opt out of Section 718.111(j), *Florida Statutes* (2008), as described above, was conducted at an open and duly noticed meeting of the Association membership on **December 4, 2008**, at 10:00 a.m., at the Association's clubhouse.
2. From the recording date of this Notice of Opt Out Vote, all repair and/or reconstruction costs and expenses addressed in Section 718.111(j), *Florida Statutes* (2008), as it may be amended from time to time, shall be allocated in

the manner provided in the **Amended and Restated Declaration of Condominium of Strathmore Riverside Villas, a Condominium, Section One**, as recorded as **Instrument #2005265829**, of the Public Records of Sarasota County, Florida, as it may be amended from time to time.
