## **Contract stipulations**

- 1. Touchups-Any quality issues directly related to Painter Bros workmanship will be fixed by Painter Bros.
- 2. Rework-Any damages/issues caused by another trade will be fixed at the cost of \$75 per man per hour plus materials in the form of a change order.
- 3. All pricing is based on documents/specifications given to Painter Bros
- 4. Unless noted otherwise, Quote is for a One Tone paint job, where the walls, ceilings, and trim in all units and hallways are the same color and sheen.
- 5. If there is a production/schedule delay prohibiting Painter Bros from adhering to the predetermined schedule, then a \$200 per day dispatch fee will be charged in the form of a change order. It is recognized that painter bros will incur costs associated with rescheduling.
- 6. It is the responsibility of Painter Bros to inspect all surfaces prior to painting to deem paintable. Any surfaces requiring additional work from prior trades poor workmanship such as drywall and millwork will need to be remedied within 48 hours of inspection. At the request of contractor, Painter Bros can remedy any previously identified issues with the paintable surfaces at an additional hourly rate of \$75 per man hour plus material. This will be in the form of a change order.
- 7. This contract does not include fixing other trades work, figured prefinished by others.
